

**Moving With The Military
MRE Cooking Challenge
Official Rules**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The Moving With The Military MRE Cooking Challenge (the "Promotion") begins at 12:00 a.m. Eastern Time ("ET") on August 22, 2017, and ends at 11:59 p.m. ("ET") on September 15, 2017 ("Contest Period"). Additionally, a Fan Favorite Vote (the "Voting Period") begins September 18, 2017 and ends September 20, 2017. Contest is sponsored by Moving With The Military.

HOW TO ENTER: Eligible participants can enter the Contest during the Promotional Period by: 1) Completing and submitting entries from our Website (<https://www.movingwiththemilitary.tv/mre-cooking-challenge> - accessible from our Contest landing page at <https://www.movingwiththemilitary.tv/mre-cooking-challenge>).

ELIGIBILITY: (a) No purchase necessary to enter or win. (b) The Contest is open to any legal U.S. residents, who are 18 years of age or older, except employees of Moving With The Military and their respective immediate family members or persons living in the same household, as well as other entities directly associated with this Contest. (c) Only one winner per household is permitted to the Contest.

Winners must be 18 years of age or older.

PROMOTION DESCRIPTION: The idea of the Moving With The Military MRE Cooking Challenge is to offer three winners, a \$200 Visa Gift Card each in the following categories.

- Most Creative Dish
- Best Presentation
- Fan Favorite

WINNER SELECTION: Selection of the two winners of Most Creative Dish and Best Presentation will be made by a panel of judges. The winner of the Fan Favorite Category will be decided by a public vote. Voting period begins September 18, 2017 and ends September 20, 2017. All winners will be announced on or around the following date: September 22, 2017 at 8 p.m. Eastern Time

Winners will be notified by the email and/or telephone number that they provided on their entry form. The winners will have 5 days to claim the prizes. The odds of winning will

depend on the total number of eligible entries received. Upon claiming, gift cards/gift certificates will be mailed to winners.
